Inspections

The St Maarten Sea Rescue Foundation is now also responsible for the inspections of private and small commercial vessels for the St Maarten ship registry.


This means that inspections of private vessels and commercial vessels with a maximum of 12 passengers need to be inspected by SSRF before registration/re-registration can occur.


The following applies;

- Inspections are always done by a team of two SSRF inspectors
- Inspections take place at the rescue office in Philipsburg (Bobbys Marina)
- Inspections are only performed on Saturday afternoon by appointment only
- A donation to the Sea Rescue is requested for each inspection
 - Up to 20 feet \$20
 - Between 21 and 40 feet \$40
 - Between 41 and 60 feet \$60
 - Over 60 feet \$100

Additional cost for the St Maarten port authorities may be applicable.
