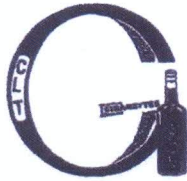


Dear Ms. Labega,
