You requested clarification on our letter of May 7, 2013. Indeed our letter signed by 8 members is dated May 6, 2013 and entered into the offices of the recorder dated May 7, 2013. Please take note that this letter of May 6, 2013 does not form the basis for our request for the meeting but only establishes the fact that 5 ministers no longer enjoy majority support from the Parliament of St. Maarten.

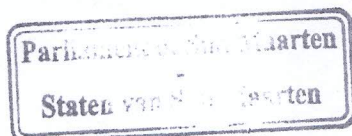


