## Parliamentary Motion of St. Maarten

The Parliament of Sint Maarten, in its meeting of today, June 23rd 2025

- The Ministry of TEAIT is currently responsible for overseeing animal welfare and activities through their department of Livestock, Agriculture & Fisheries (LVV)

  The Ministry of VSA is responsible for Public Health and Community Development and Family Affairs That LVV issues permits for importation of animals without an administrative fee attached. Veterinary medicine is an integral part of public health and plays a crucial role in safeguarding human health and well-being through various contributions, including disease prevention, food safety, and biomedical responsible.

  The proliferation of stray animals on Sint Maarten poses significant risks to public health which can be fatal or cause severe illness in humans.

  Stray animals are a primary vector for several infectious diseases such as leptospirosis, ringworm and echinococcosis, with bites and contact with contaminated surfaces or waste serving as common
- transmission routes.
  Environmental contamination occurs through fecal shedding of pathogens and stray animals that aren't treated, increases the risk of parasitic and bacterial infections in the community, especially among children and the vulnerable populations.

  Aggressive behavior from unsterilized stray animals contributes to injuries, psychological trauma, and increased demand for healthcare services.

  Mass sterilization programs are internationally recognized as the most humane and effective method to control the stray animal population, reduce disease transmission, and protect public health without resorting to culling.

  Successful sterilization campaigns in other regions have demonstrated a reduction in stray animal numbers, fewer human-animal conflicts, and a measurable decrease in disease incidence.

- Reducing the stray dogs population through sterilization directly lowers the risk of zoonotic disease transmission, decreases environmental contamination, and mitigates aggressive behavior and bites and
- transmission, decreases environmental contamination, and mitigates aggressive behavior and bites and prevent road accidents.

  A focused, well-funded sterilization campaign will provide long-term cost savings for public health by preventing outbreaks and reducing the need for emergency interventions.

  Collaboration with local veterinarians and animal welfare organizations ensures efficient use of resources, maximizes the number of animals sterilized, and enhances community engagement and education.

  Investing in sterilization aligns with global best practices for public health and animal welfare, supporting Sint Maarten's reputation as a safe and responsible destination for residents and visitors.

### Resolve:

To allocate an amount of XCG 45.000.00 from the budgets of the Ministry of TEATT and VSA for a
comprehensive sterilization campaign targeting stray animals on Sint Maarten, with the primary

objective of reducing public health risks associated with zoonotic diseases and environmental

- objective of reducing public health risks associated with scanning and neutering stray animals, necessary postcontamination.

  To ensure the campaign covers the costs of spaying and neutering stray animals, necessary postoperative care, and public awareness initiatives to promote responsible animal management.

  So That a progress report be abmitted by both the Ministries of TEATT and VSA to Parliament within six
  months of the campaign's commencement, detailing the number of animals sterilized, funds utilized, and
  measurable public health outcomes.

  That the Ministry of TEATT adjust its legislation necessary to levy a fee for animal imports to
  structurally support this program.

  That this motion takes effect immediately upon approval.

  Accelerate construction and upgrading of affordable homes under SMHDF, prioritizing resilience and basic services.

  Present, within 90 days, a detailed plan to Parliament for the construction and delivery of new affordable housing units, in collaboration with relevant stakeholders, including clear targets, timelines, and funding sources.

  Evaluate, increase and implement the rent subsidy program

  Explore new funding for social housing projects and neighborhood improvements.

  Engage private sector and NGOs to increase affordable housing options.

  Report to Parliament every six months on the progress of affordable housing construction, the impact of the rent subsidy program, and the effectiveness of measures to address housing quality, maintenance, and tenant satisfaction.

The Parliament of Sint Maarten, in the meeting of June 23rd, 2025

- lering:

  The previous motions dated April 18, 2013, unanimously adopted by all 13 members present, and January 29, 2011, unanimously endorsed by all 15 members of Parliament, both of which called for urgent action on national energy diversification and sustainability.

  The imperative for the Government of Sint Maarten to promptly execute these proposed measures in light of ongoing energy security, economic, and environmental concerns. The rising global and regional momentum toward fuel diversification, including the adoption of cleaner alternatives such as Liquid Natural Cas (LNG), to ensure long-term energy resilience and competitiveness. The critical role of the harbor and G.E.B.E. in facilitating energy transition and supporting economic growth, as well as the need to optimize operational efficiency and cost-effectiveness for the benefit of all citizens.

- Resolves:

  To request the Government of Sint Maarten to:

  Request the Supervisory Boards of G.E.B.E. and the Harbor Group of Companies to develop and present a comprehensive plan for the implementation of fuel diversification strategies, including but not limited to LNG and other sustainable energy sources, for the country.

  Request the Supervisory Boards to tender a fair and transparent proposal that supports all citizens of Sint Maarten and investigates new income-generating and cost-cutting measures to accommodate all vessels docking at the harbor, as well as all operations at the G.E.B.E. power plant.

  Urge the government to make a policy to enable the supply of fuel and electrical power to cruise ships docked at the harbor, allowing them to conserve their own fuel, and to provide LNG to ships that have already transitioned to LNG usage, thereby positioning Sint Maarten as a regional leader in green port operations.

  Request the Board of G.E.B.E. to explore the technical and financial feasibility of transitioning from heavy fuels to LNG for local power generation, and to report findings and recommendations to Parliament no later than 15% October 2025.

  Upon agreement on terms, direct the Government, the Supervisory Boards of the Harbor Group of Companies,
  - October 2025.

    Upon agreement on terms, direct the Government, the Supervisory Boards of the Harbor Group of Companies, and G.E.B.E. to establish a joint venture for the procurement, storage, and distribution of LNG or alternative fuels, ensuring that the cost per kilowatt hour does not exceed the prevailing ceiling set throughout the Caribbean
  - fuels, ensuring that the cost per knowar nour occasions are proposed from the concessionaire provide specified contributions for public street lighting and support for solar-rechargeable equipment at key sporting facilities, including but not limited to Raoul Sports Complex, Jose Lake, John Cooper Junior, the Little League field in Philipsburg, and the Philipsburg Sports Auditorium, to ensure their independent operation and resilience, with additional support from donated generators.

    Require regular progress reports to Parliament on the status of these initiatives and the measurable
