To mark the occasion in a dignified and solemn manner, an ecumenical service will be held at the St. Martin of Tours Catholic Church on Frontstreet at 8:30 – 9:45 AM.

It's further proposed that a Special Plenary Session of Parliament be convened shortly after the ecumenical service at 10:00 – 11:00 AM to which all members of the Council of Ministers will be invited. This proposed session should be carried out under the auspices of parliament. The scheduled speakers are the Prime Minister, Deputy Prime Minister Chairlady of Parliament and the Faction Leaders who will address the topic of "The Experience of the New Constitutional Status".

From 10:00 AM refreshments will be served to civil servants as a recognition and appreciation for their patience and resolve in enduring and managing the unchartered course that was set for country St. Martin. The civil servants will passively participate in the parliamentary session by use of viewing the session via internet on three screens at the Celebration Palace, At 11:15 AM the Prime Minister who is also charged with the Human Resource department and the Minister of Culture will welcome all civil servants to a special motivational session in which a civil servant as well as someone from the private sector will deliver the key note, address. The motivational session will come to a close at 12:30 PM.

In keeping with the Constitution of St. Martin, a National Anthem must be adopted. Considering that this is a historic day, it merits that the competition of composing a National Anthem be announced.

In order to guarantee the widest possible public participation in this process a competition will be held, in which all citizens of St. Martin as well as St. Martiners living abroad are eligible to participate. The minimum requirement is that the person(s) entering the competition must be of Dutch nationality and must be 18 years of age.
