***The decision of Government to establish a committee to conduct an investigation on integrity within the Government of Sint Maarten.***

The reason for requesting this meeting as an urgent meeting is the following. Clarity is needed on the matter of investigating integrity within the Government of Sint Maarten.

- On September 30<sup>th</sup>, 2013 a Kingdom Decree was issued instructing the Governor of Sint Maarten to conduct an investigation into the integrity of the Government of Sint Maarten.
- On several occasions over the past weeks, the Prime Minister publicly announced that the Government of Sint Maarten has agreed to have Transparency International conduct an Integrity Assessment into the Government of Sint Maarten.
- And now on Tuesday October 15<sup>th</sup>, 2013 the Government of Sint Maarten has taken a decision to establish its own committee to conduct an investigation on integrity within the Government of Sint Maarten.

This all seems rather confusing and contradictory and warrants an explanation and the public in general deserves clarity in this entire matter.

We also request the presence of the Minister of General Affairs in the meeting to provide clarity and information and to answer to questions from Members of Parliament.
